



KenCrest Community Options Family and Friend Visitation Protocol (as of June 22nd, 2020)

Our new visitation policy will take effect on June 22nd, and may be revised at any time—based on guidance from state authorities, health departments, and at KenCrest’s discretion.

When you arrive at your loved one’s home, you will be asked to sign off on the following directives. Please take time to review them prior to scheduling your visit, so you will be prepared to support our mutual goals for safety. By participating in a family visit you are agreeing to the following:

- Visitors will schedule their visits with their loved one(s) seven (7) days in advance
- Each family will be assigned a specific day and time frame to visit and will not arrive prior, nor later than that scheduled time frame
- Unscheduled visits will not be permitted
- Only one family may visit a home at a time
- No more than two (2) visitors from one family may visit at a time
- No one under the age of 14 is permitted to visit a home
- Visitors must be COVID-19 symptom-free, and have not been **exposed** to anyone who tested positive for COVID-19 in the last 14 days
- Visitors must take their temperatures prior to their visit; if their temperature is 100.4 degrees or higher, the visit must be rescheduled
- Visitors must bring their own masks
- Masks or mask alternative must be worn at all times
- Residents must wear masks, as tolerated
- **Visits must take place outside**; if the weather does not permit the visit will be rescheduled
- **Social distancing must be maintained at all times**; although it’s difficult, please try to refrain from physical displays of affection
- If you need to enter the home to use the bathroom please sanitize your hands before entering the home
- If it is a single person home, the visit may occur inside; a specific area in the home will be designated for visits so that staff may maintain social distancing from the visitors
 - Inside visits to Lifesharing provider homes will be left to the discretion of Lifesharing providers
- **If any visitor experiences a change in health status prior to their visit or thereafter their visit, based on the CDC symptoms for COVID-19, they must notify the residential program manager, nurse house manager, or the Lifesharing personal outcome champion immediately**
- Community outings with family members are permitted if the Community Living or Lifesharing resident is able to wear a mask; only three (3) people, including the resident, are permitted in the family vehicle at one time

- Community outings will be limited in scope; no more than three (3) people participating in the outing
- **We are limiting overnight visits amongst Community Living and Lifesharing residents at this time**
- No eating is permitted during visits at KenCrest homes
- Visits will be cancelled at any time if any individual in the home becomes ill

Any violation of these terms will result in a termination of the visit. These visits will be monitored by our Direct Support Professionals, nurses, or Lifesharing family members to ensure that protocols are being followed.
